Notice Concerning Changes in Organization, Change of President and Changes in Representative Corporate Executive Officers and Other Personnel

Mitsubishi Estate Co., Ltd. (hereafter "Mitsubishi Estate" or "the Company") hereby announces that it has decided to make the following organizational changes: change of President and changes in Representative Corporate Executive Officers and other personnel as well as candidates for Directors to be submitted at the Ordinary General Meeting of Shareholders scheduled to be held in the latter half of June 2023, and candidates for committee members of the Nominating Committee, Audit Committee and Remuneration Committee to be submitted at the Board of Directors' Meeting to be held after the Ordinary General Meeting of Shareholders.

#### I. Organizational Changes

[Effective as of April 1, 2023]

The Company will make the following organizational changes with a view to achieve further growth in the future.

#### 1. Innovation and Business Transformation Group

(1) Transfer to 5G Infrastructure Sharing Business Office

The 5G Infrastructure Sharing Business Office of the DX Promotion Department will be transferred to the Business Creation Department to integrate the management of the 5G Infrastructure Sharing Business, which has progressed through phases in the business lifecycle, with other new business projects in the Business Creation Department, which has accumulated know-how on the creation, operation and governance of new businesses.

#### 2. Commercial Property Business Group

(1) Launch of Okinawa Business Planning Office
Okinawa Business Planning Office will be established in the Commercial Property Business Planning
Department as an organization responsible for developing of business strategies in Okinawa.

(2) Transfer of functions of the Open Innovation Promotion Office

The Open Innovation Promotion Office of the Area Management Planning Department will be constructively dissolved, and its functions will be transferred to the xTECH Leasing and Promotion Department to promote open innovation for towns, which will contribute to improving profit and streamlining the Commercial Property Business, as well as to the efficient implementation of various open innovation initiatives.

#### (3) Transfer of the OCA TOKYO Business Promotion Office

The OCA TOKYO Business Promotion Office of the Commercial Property Management Department will be transferred to the Flexible Workspace Planning and Operation Department to facilitate the evolution of various services ancillary to the provision of diverse workspace and to promote collaboration with communities fostered among the members of OCA TOKYO, a private club.

(4) Integration of the Facility Management Planning Department into the Commercial Property Management Department

The Facility Management Planning Department will be integrated into the Commercial Property Management Department to efficiently implement comprehensive asset management, including technological aspects, regarding the real estate for which the Commercial Property Business Group is responsible.

#### 3. Residential Business Group

(1) Renaming the CLT Business, Residential Land & Recreational Facilities Management Office the CLT Business, Residential Land & Recreational Facilities Management Department, and launching the Wood Design Business Promotion Office

The CLT Business, Residential Land & Recreational Facilities Management Office will be renamed the CLT Business, Residential Land & Recreational Facilities Management Department, and the Wood Design Business Promotion Office will be established to promote the positive use of wood in view of the growing attention on the wood design business and future needs.

#### 4. Branches

(1) Renaming the Umekita Development Office the GRAND GREEN OSAKA Office

The Umekita Development Office of the Kansai Branch will be renamed the GRAND GREEN OSAKA Office in line with the decision on the name of the town block in the Umekita Development project.
